Michele thought that some people would not return after break and felt that there should be some kind of language stating that GSR's are required to return from a break. Steve thought that attendance would need to be retaken after a break. Libby felt that she was not a part of during a break because she is unable to be around cigarette smoke. Doreen asked if we could vote on the Motion.

Motion 1: Cathy W. proposed a motion to eliminate break from the format. Motion failed. 10-6-0. A 2/3 majority is necessary for a policy change. Break will still be part of our format.
