There was discussion regarding whether or not if a subcommittee brings an new or amended internal guideline to the RSC and no one objects to it, does that mean the RSC has accepted that change de facto? Some say no... a subcommittee can't create internal guidelines that conflict with RSC Policy. In order to change RSC Policy a motion must be made and passed at the RSC meeting. Eventually...
